Service Definitions:

Targeted Case Management (TCM)

A Targeted Case Manager assists a person in gaining access to medical, social, educational, and other needed services through assessment, support plan development, referral and monitoring. Case Management is available to anyone who is eligible for I/DD services in Butler County.

Supportive Home Care (Agency-Directed)

Supportive Home Care agencies provide staff for individualized (one-to-one) support to individuals living with family or foster families while the individual is typically not sleeping.

Personal Care Services (Self-Directed)

Family members are responsible for finding staff to provide individualized (one-to-one) support to individuals living in the family home while the individual is typically not sleeping

Enhanced Care Services

Enhanced Care services provides supervision and/or non-nursing physical assistance during an individual's normal sleeping hours in his/her place of residence.

Overnight Respite

Overnight Respite provides temporary overnight relief for the individual's family member who serves as an unpaid primary caregiver.

Specialized Medical Care

Specialized Medical Care provides long-term nursing support for medically fragile and technology dependent individuals. The provider of Specialized Medical Care must be a Registered Nurse (RN), a Licensed Practical Nurse (LPN) or another entity designated by the Kansas Department for Aging and Disability Services.

Financial Management Services

Financial Management Service provides administrative and payroll services for people who self-direct in-home services.

Day Services (ages 18+)

Day services consist of regularly occurring activities that provide a sense of participation and contribution to the community, outside of the home. These activities also are designed to maintain or increase adaptive capabilities, independence, productivity, and inclusion. They may include facility-based work services, work crews, competitive employment in the community, volunteer opportunities, social events, and other community-based activities.

Residential Services (ages 18+)

Residential services provide assistance with activities of daily living, household tasks, socialization/recreational opportunities and other adaptive skills to increase independence in a non-family home. Services can range from a few hours of support to live-in or around the clock care.

Supported Employment

Supported Employment provides support services to individuals ages 18+ to secure and maintain competitive, integrated employment. This service provides support in the way of a "job coach" who provides ongoing supports necessary for employment as identified in the Person-Centered Support Plan

Wellness Monitoring

Monitoring which provides evaluation and regularly scheduled nursing visits by an RN for individuals who have medical conditions that require ongoing oversight. The nurse monitors for changes in the individual's health/wellbeing and assist in following recommendations by the physician.

Assistive Services

These are supports or items that are designed to enhance an individual's independence or abilities by obtaining adaptive equipment, assistive technology, or home modifications.

Medical Alert Rental

Medical Alert provides a small device carried or worn by an individual to provide access to emergency assistance 24 hours a day.
